

## **TERRYTOWN COUNTRY CLUB**

### **GENERAL RULES**

1. HOURS. The Board of Directors shall determine hours of operation of House facilities. Variations of time will depend on the season, weather and utilization of the facilities. Hours of operation of all Club facilities will be properly posted and all members notified through bulletins, and other means. The pool & clubhouse will normally be closed on Mondays. Pool will be closed to members October through April.
2. MEMBERS: Each member is expected to conduct themselves in accordance with the rules of common sense and courtesy. No fighting (physical or otherwise) will be tolerated. Language should be appropriate and without profanity. Membership can be revoked by the Board of Directors for any reason at any time without the benefit of refund.
3. GUESTS. (a) Any member shall have the privilege of introducing guest to the Club, however, Members shall be responsible for the conduct and indebtedness of the guests introduced by them; (b) Club functions may be closed to non-members when deemed necessary by the Board of Directors; (c) **former members are not allowed to return as guests for one (1) year after resigning their membership unless they have moved more than 50 miles from the club;** and (d) **No guest shall be permitted to use the club facilities unless the sponsoring member is present and guest fees are paid at the time of attendance.**
4. EQUIPMENT: No equipment or furnishings belonging to the Club shall be loaned or removed from the Club premises or moved from its appointed place without special permission of the General Manager.
5. DAMAGE OR DESTRUCTION OF CLUB PROPERTY. Damage or destruction caused by members or their guest, of equipment, furnishings or any property belonging to the Club shall be paid for by the members responsible for it.
6. SMOKING: Smoking is permitted in designated areas only and be properly disposed of in the approved receptacles provided.
7. FIREWORKS. The setting off of any kind of fireworks on the grounds is strictly prohibited, except when authorized by Club management as part of entertainment organized for the membership.
8. BULLETIN BOARDS. Nothing shall be posted on the Bulletin Boards except by authority of the Manager or Board of Directors.
9. CLUB EMPLOYEES: Members and their guests may not abuse any club's employees, verbally or otherwise. All service employees of the Club are under the supervision of the Board of Directors and no member or guest shall reprimand or discipline any employee or send any employee off Club Facilities for any reason. Any employee not rendering courteous and prompt service should be reported to the Manager and Board of Directors immediately.
10. COMPLAINTS AND SUGGESTIONS: Complaints and suggestions are invited and should be made in writing to the Board of Directors.

## POOL RULES

Safe Swimming is simply following the rules of common sense and courtesy. It is the duty of the Manager and Lifeguards to see that the rules are observed and that no one suffers because of the thoughtlessness of another.

Strict Observance of the Rules and Regulations will insure maximum enjoyment and benefits for the membership. Any infraction of such Rules and Regulations shall subject the member and/or his child or children to suspension of Pool privileges for a period to be determined by the Manager and Board of Directors.

### **THE FIRST TWO RULES ARE REQUIREMENTS OF THE AMERICAN PUBLIC HEALTH ASSOCIATION**

- 1. All persons using the Swimming Pool should take a shower with warm water and soap before donning a suit to enter the water.**
- 2. Any Person with a cold, fever, cough, inflamed eyes, or any skin disease, wearing bandages or with any communicable disease shall be excluded from the Swimming Pool.**
3. ALL Members and Guests must sign in upon arrival.
4. Appropriate swim wear is required in the pool. No cutoffs or other inappropriate apparel allowed. Children who are not toilet trained must wear a swim diaper.
5. Only swim goggles (that cover the eyes only) are allowed. No masks, snorkels or fins are allowed.
6. No water guns of any kind are allowed in the pool or on the grounds.
7. All persons using the pool do so at their own risk. Terrytown Country Club will not be responsible for any accident or injury in connection with such use.
8. Outside food or beverage is permitted in the pool area, however, NO GLASS or breakable containers are allowed in the pool area. Food and beverage is available for purchase at the pool in the Concession Stand. Chewing gum is not permitted in the pool area
9. Terrytown Country Club will not be responsible for loss or damage to any personal property.
10. Parents are responsible for the conduct and safety of their children using the facilities.
11. All children under the age of 12 years must be under the supervision of a parent or designated care giver, regardless of swimming ability. Care givers must be 16 years of age or older.
12. Lifeguard breaks are taken every hour for 10 minutes. ONLY adults (18 years of age or older) are allowed in the pool during the lifeguard breaks. NO ONE is allowed on the diving board or in the diving well during lifeguard breaks.
13. Chewing gum and sunflower seeds are not permitted in the pool area.
- 14. No running, pushing, or causing undue disturbances in or around the pool area.**

15. Flotation devices should not be of unreasonable size or weight and may not contain offensive graphics. All flotation devices must be in good condition. The Manager or lifeguards may ask you to discontinue using any flotation device permanently or for the day if they determine that the device is inappropriate for the pool or the conditions.
16. Lap lanes are reserved for continuous swimming.
17. Only one person is allowed on the diving board at any given time. Divers should remain on the deck until the previous diver is clear.
18. No flotation devices, swimming rings or inner tubes of any kind are allowed when using the diving board.
19. No one (regardless of age) is allowed on the diving board or in the diving well without a lifeguard on the stand.
20. The manager will be in charge at all times and will have the authority to enforce all rules, including limiting activities of anyone disturbing the enjoyment or safety of others.
21. The pool area will be cleared during all thunderstorms. During rain showers, the lifeguard will clear the pool at his/her discretion.
22. No Member or guest shall take any property belonging to the Club from the pool area. Members are liable for property damaged or destroyed by themselves or their guests.
23. The Manager may close without notice all or any part of the pool for maintenance, weather conditions, swim meets, classes, or clinics.
24. The cost of any property damage will be charged to the responsible Member.
- 25. Pool hours are strictly enforced and may change at the discretion of Club Management.**
26. No pets are permitted in the pool area with the exception of necessary service animals (proper identification may be requested).
27. All personal injury, regardless of how slight, must be reported to a manager or lifeguard immediately.

**Failure to abide by these rules may result in a warning, suspension, or expulsion from the club in accordance with the policies of the Club at the time of the infraction.**
